## SUPPLEMENTAL DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR PINE CREEK VILLAGE AT BRIARGATE

THIS SUPPLEMENTAL DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS is made as of November 10, 1998 hereof by LP47, LLC d/b/a La Plata Investments, a Colorado limited liability company (the "Declarant").

**WHEREAS**, the following described real property is part of the Properties and subject to the Declaration:

Lots 1 through 20, inclusive, Tracts A, B, C, D, E, and F, Pine Creek Subdivision Filing No. 8, according to the plat thereof recorded on December 28, 1998 at Reception No. 98190918 of the records of El Paso County, Colorado (hereinafter "Filing No. 8"),

NOW, THEREFORE, the Declarant hereby redesignates the boundaries of the Blossom Hill Neighborhood to incorporate all of that real estate located in Filing No. 7 and Filing No. 8.
